

**BfR Recommendation for NEUKASIL RTV Addition Systems**

**NEUKASIL RTV 20 with NEUKASIL Crosslinker A 2 colourless / blue/ black/ Crosslinker A 26 blue / colourless and Crosslinker A 117 olive-green**

**NEUKASIL RTV 23 with NEUKASIL Crosslinker A 7 colourless / blue, NEUKASIL Crosslinker A 14 and NEUKASIL Crosslinker A 18 colourless / blue**

**NEUKASIL RTV 25 with NEUKASIL Crosslinker A 1 colourless / blue and NEUKASIL Crosslinker A 2 colourless / blue / black**

**NEUKASIL RTV 22 F with NEUKASIL Crosslinker A 142 F**

In Recommendation XV. "Silicones" dated 2014-10-01, The Federal Institute for Risk Assessment in Berlin (BfR) treats silicone polymers (silicone oils, silicone resins, silicone elastomers).

The above mentioned **NEUKASIL RTV** Addition Systems comply in their material composition in the sense of § 2 section 6 no. 1 and § 2 section 6 no. 3 with the Food and Feed Code as far as the consumer goods are suitable for the intended use and the conditions mentioned in the Recommendation are observed. Also considered in this Recommendation are consumer goods in the sense of § 2 section 6 no. 3 which are mentioned in part III (silicone elastomers) no. 4.

The fillers used comply with the preconditions for the production of food items and consumer goods in the sense of § 2 section 6 no. 1 of the Food and Consumer Goods Act of Recommendation LII. Fillers as of 2012-01-01.

When our instructions for use are observed, also the requirements on the finished product made in the above mentioned Recommendation of the BfR are met, that means the proportions of volatile organic and extractable parts lie each time below the 0.5 % mentioned therein.

The processing of our products is beyond our control so that it is pointed out that this declaration does not relieve the producer of finished products of the duty to check his product made from NEUKASIL RTV for approval.
